

# THE PROFESSOR

Originally from rural Manitoba, Ryan Gibson has a deep intrigue and respect for rural communities, rural people, and the events that shape their futures. Growing up witnessing the transformations in rural development, agriculture, and their influence on communities instilled a fascination and commitment to rural issues. Over the past years Ryan has been a student, practitioner, and admirer of rural populations, dynamics, and interactions. Ryan's research and community engagement focuses on rural and regional development, governance, philanthropy, and public policy.

In June 2015, Ryan was elected President of the Canadian Community Economic Development Network; a national organization committed to strengthening communities by creating economic opportunities that enhance social and environmental conditions. Ryan is the Past President of the Canadian Rural Revitalization Foundation and holds appointments with the Rural Development Institute (Brandon University), the International Centre for Northern Governance and Development (University of Saskatchewan), Institute of Island Studies (University of Prince Edward Island), Saint Mary's University, and Assiniboine Community College.

Ryan came to the University of Guelph in the summer 2016 to begin the Libro Professor in Regional Economic Development position.

## TEACHING

Dver the past year the Professor taught two courses n the School of Environmental Design and Rural Development: Regional Planning, and Community Economic Development. Further, three independent courses were facilitated focusing on social housing, the Community Futures Program, and comparative cural definitions and their applications.

## RESEARCH

The Professor was actively engaged in research initiatives focused on economic development, public policy, philanthropy/wealth, and employment. Over the past year, 9 new research projects worth over \$430,000 have been received. Illustrative description of the research initiatives are enclosed in this report.





## SERVICE AND ENGAGEMENT

The Libro Professor has been actively involved in service and community engagement commitments within the university, within the region, and with the professional community. The Libro Professor met with over 25 community groups, delivered 16 presentations and workshops, 5 guest lectures, 7 articles/book chapters, 4 reports, organized 7 events, and testified as an expert witness on three occasions.

## SCHOOL OF ENVIRONMENTAL DESIGN AND RURAL DEVELPMENT

The School of Environmental Design and Rural Development brings together major academic fields concerned with creating strong communities, in Canada and around the world. The four highly respected units that have come together to form SEDRD share many common goals but approach them in different and complementary ways. This model reflects the imperatives in building authentic communities where planners, leaders, communicators, landscape architects, the citizens and politicians all play important interdependent roles in community strength.

# BUILDING STUDENT CAPACITY

Students are an integral focus of the Libro Professorship. Dr. Gibson strives to create research, networking, and capacity building skills development opportunities for students. These opportunities and skills will be valuable assets as students transition to the workforce. Over the 2016-2017 year, Dr. Gibson facilitated over 54 student capacity building opportunities.


## RESEARCH ASSISTANT POSITIONS

# INFLUENCING PUBLIC POLICY

Influencing change in public policy is a key activity of the Libro Professorship. Over the past year, the Professor has met with community-based organizations, nonprofit organizations, provincial governments, and national governments to provide evidence, knowledge, and insights on rural and regional economic development. Four key activities from the past year are outlined below.

### TESTIMONY TO SENATE COMMITTE ON NATIONAL FINANCE

What is the future role for the Government of Canada in rural infrastructure? Dr. Ryan Gibson presented to the Senate Committee on National Finance regarding rural infrastructure investment. The Senate Committee has been studying the design and delivery of the government's infrastructure commitment, and has asked for comments to address the effects of future infrastructure investments on rural development in Canada. #### 2 TESTIMONY TO HOUSE OF COMMONS FINANCE COMMITTEE

Dr. Gibson testified before the House of Commons Standing Committee on Finance to discuss alternative local economic development strategies that could be pursued by the federal government on October 20, 2016 in Québec City. On September 12, 2016, Dr. Gibson participated as a discussant at the rural proofing workshop hosted by the Swedish Agency for Growth Policy Analysis. # ADVANCING RESEARCH

The Libro Professor is actively engaged in research initiatives focused on critical topics of regional and rural development. Dr. Gibson's main research interests focus on regional economic development, multi-community collaboration and governance, philanthropy and wealth, and public policy.

In 2016-2017, Dr. Gibson received funding for 9 new research initiatives worth in excess of \$400,000 (noted in orange). These research initiatives focus on better understanding how to build vibrant economies, the role of philanthropy in community planning, and evaluations of rural policies. These research initiatives engage other researchers from across Canada and internationally, university students, and community-based organizations.

Dr. Gibson is also actively engaged in 6 additional research initiatives that started before 2016. These initiatives (noted in blue) focus on enhancing our understanding of precarious employment, community resilience, workforce development, rural policy, and knowledge mobilization.

Throughout the past year, a number of research proposals have been submitted for consideration to funding agencies. There are currently 5 research proposals under review (noted in yellow). These research proposals will be adjudicated over the coming months. Stay tuned for more information.

## **RURAL PHILANTHROPY**

Social Sciences and Humanities Research Council of

Canada, 2017-2021

Rural communities are sites of wealth, fuelling the Canadian economy through natural resource industries. Although rural is a source of wealth, over the past 30 years this wealth has largely been redirected out of rural regions to larger urban centres. This issue is exacerbated by processes of globalization, which facilitate the hyper-mobility of finance. Finance is no longer tied to place. A counterbalance to these trends is the emergence of philanthropic organizations in Canada that have been exploring and implementing place-based collective endowments as a response to re-embedding finance in local areas. Philanthropic organizations can collect money to invest in place-based collective endowments.

This research will examine place-based collective endowments as a mechanism to facilitate revitalization in peripheral regions from theoretical, public policy, and local development perspectives. Find out more here.




## Ontario Ministry of Agriculture, Food and Rural Affairs, 2017-2020

How effective are provincial rural development policy interventions? How do we know if the intervention was a 'good' or 'effective' investment of public funds? These questions will be examined through this initiative. Examining provincial experiences in designing, implementing, and evaluating rural policies and program will serve to advance rural development in Ontario.

This research initiative will analyze provincial rural policies and programs from across Canada to understand what makes good, effective rural strategies. The findings from this research will provide the government of Ontario evidencebased recommendations for constructing and implementing successful rural policies and programs.

## RURAL PROOFING IN CANADA

#### Government of Sweden, 2016-2017

This research focused on the experience of Canadian Rural Secretariat and its application of a "rural lens" or rural proofing. During its existence, the Rural Secretariat coordinated the federal government's focus on rural issues, delivered a series of programs and advocated for rural policy. The Rural Lens was created as a policy tool to review federal policies and programs from the perspectives of people living in rural and remote regions. The rural lens was designed to be applied by any government department early in the development of a program or policy using a guide prepared by the Rural Secretariat.

This research examined the impacts and effectiveness of the Rural Lens and geneated key lessons learned from the Canadian experience. For more information and to read the final report click here.


