
2018-2019 Annual Report






ILLUSTRATIVE STUDENT ENGAGEMENT



INFLUENCING PUBLIC POLICY

Influencing change in public policy is a key activity of the Libro Professorship. Over the past year, the Professor has met with community-based organizations, nonprofit organizations, provincial governments, and national governments to provide evidence, knowledge, and insights on rural and regional economic development. Four key activities from the past year are outlined below.

NATIONAL CBC RADIO INTERVIEWS ON RURAL DEVELOPMENT

Dr. Gibson participated in 11 CBC Radio interviews to discuss the new federal minister of rural economic development. Details can be found by clicking here, including a recording of the interview the CBC Radio Morning with Wei Chen.

2019 FEDERAL BUDGET SUBMISSION

Dr. Gibson was invited by the House of Commons Finance Committee to bring perspectives on how the 2019 federal budget could be utilized to enhance and support local economic development in rural and northern communities. The committee is studying the pre-budget consultations and more specifically what steps the federal government can take to support and encourage Canadian businesses to grow the economy in the face of a changing economic landscape.





MEETINGS WITH PARLIAMENTARY ASSISTANT TO MINISTER OF RURAL ECONOMIC DEVELOPMENT

Dr. Gibson met with the Marc Serré (Member of Parlimanet for Nickel Belt), the Parliamentary Assistant the Minister of Rural Economic Development, to discuss rural economic development in Canada and potential strategies the federal government of Canada may employ to empower rural regions to compete in the global economy.

Dr. Gibson was part of a team that submitted a set of recommendations to the federal Ministry of Finance for the 2019 budget. The recommendations focused on how the federal budget could better support local community development. 

ADVANCING RESEARCH

The Libro Professor is actively engaged in research initiatives focused on critical topics of regional and rural development. In 2018-2019, Dr. Gibson received funding for **6 new** research initiatives worth in excess of \$200,000.

Each of these research initiatives, along with ongoing research activities, engages a series partners, including communities, organizations, nonprofits, local governments, Indigenous communities, provincial government ministries, federal government ministries, and international partners. CHARTING A NEW COURSE IN RURAL ECONOMIC DEVELOPMENT

2019 - 2020

What is the future of rural economic development? How can communities with low population densities and typically high distances to density carve out a place in the ever-interconnected and globalized world? How can technological and transportation innovations be utilized to sustain and revitalize rural regions? What is the role of all stakeholders in this new reality for rural economic development?

These questions are fundamental to the future of rural regions. Rapidly changing technological, political and other conditions, yesterday's solutions or assumed solutions are now being aggressively challenged. Changing senior government priorities and resources availabilities are pressing governments, communities & civil society organizations to reconsider their roles in the area and regional development agenda, and pressing for innovative approaches to governance. Community leaders, economic development practitioners, government policy makers, businesses, and researchers are striving to find answers to build and sustain vibrant rural regions.

This initiative focuses on building networks across rural economic development practitioners, policy makers, businesses, and researchers in Ontario and Ireland. The initiative will facilitate linkages between Community Futures organizations in Ontario with Leader groups in Ireland to generate knowledge sharing of successful practices, create an invaluable network, and identify seminal questions required to advancing rural economic development in this new rural reality.

SUSTAINABILITY OF NONPROFIT ORGANIZATIONS

2019 - 2020

Shifts in government restructuring led to an increasingly critical role of non-profit organizations and charities presence in rural communities. These organizations are integral to the social, cultural, economic and environmental fabric necessary to the resilience and revitalization of rural communities. However, they experience systemic organizational capacity and human capital challenges, as well as precarious funding and heavy administrative reporting burdens. These challenges impact the long-term sustainability of non-profit and charitable organizations and the ability to deliver their mandate.

The overall objective of this project is to identify and understand the critical factors that contribute to successful governance of non-profit organizations and charities in rural communities and what strategies and practices have been successful in other places.

TRANSITIONING TO THE NEW RURAL CANNABIS ECONOMY

2018 - 2020

Over the last 40 years or more, rural communities from the coastal islands, Fraser Valley, Okanagan and Kootenay region grew into cannabis producing clusters. While the outlaw cannabis industry was largely ignored and certainly excluded from economic contributions up until recently, it has been a significant, yet largely hidden part of the socioeconomic fabric of rural B.C. communities for decades. With the Kootenay region as the case study, the project goal is to evaluate how historically producing rural regions can effectively transition to the new legal cannabis economy.

Questions guiding this project include: To what extent has the cannabis industry supported rural B.C. economies? How will rural communities historically supported by the cannabis industry be impacted socially and economically with legalization of recreational cannabis? Who are the legalization stakeholders and how are they engaging in decision making? What training and education is needed for the rural workforce in response to legalization? What barriers exist for current cannabis industry participants to transition into the legalized regime? What opportunities and challenges come with legalization?

2 PROVINCIAL-TERRITORIAL RURAL DEVELOPMENT MEETING


